# Merging Hearts Holistic Center

## Artist Contract Merging Hearts Art Gallery

### The Artist Agrees to the Following:

- [ Gallery shows are juried. Works will be accepted according to wall space, content, appropriateness of subject matter, and conformance to this prospectus. Jurors are the Merging Hearts Art Gallery Coordinators.
- [ The artist is responsible for a \$35 hanging fee.
- [ We can arrange an artist reception for a \$15 fee which includes punch, cookies, chocolates and/or nuts; anything beyond that is the artist's responsibility.
- [ Prior to the show (by the 10<sup>th</sup> of the previous month), the artist will provide the exhibit title, exhibit description, artist's biography and photo. This information will be used to publicize the show in the Merging Hearts newsletter, website, in press releases, and on social media networks.
- [ Prior to delivery of artwork to Merging Hearts Gallery, the artist will provide a detailed inventory with titles and prices. The artist will mark works not offered for sale 'NFS.' If artwork is for sale 'unframed,' it must be noted with the price.
- [ Sales through the Gallery are split as follows: 50% donation to Merging Hearts; 50% to the artist. Gallery sales of work shown at the gallery for one month after the show ends will be on an honor system.
- [ The artist is responsible for sales tax.
- [ Payment for the sold artwork is mailed to the artist within 30 days after the exhibit end date.
- [ Gallery shows are scheduled in four and eight week segments, or as agreed upon by the artist and gallery coordinators.
- [ Show pieces must remain in the Gallery until the end of the show. Sold pieces may be removed during the show only if the sale depends on it or if the piece can be replaced.
- [ Gallery Coordinators welcome the advice and assistance of the artist when hanging the show.
- [ All two-dimensional pieces must be framed, wired and gallery-ready.

- [ Special installation requirements must be provided by the artist; pedestals and secure cases are not provided.
- [ Every effort will be made to protect artwork in the gallery; however neither Merging Hearts Holistic Center nor Merging Hearts Art Gallery, nor the Coordinators are responsible for loss or damage of submitted artwork.
- [ Submission of artwork for this exhibit implies acceptance of all conditions set forth in this prospectus. Applicants, by the signature affixed below, attest to the understanding that this is a cooperative endeavor. Permission to photograph any artwork in the exhibition for publicity purposes or for documentation is considered granted.
